



## TERMS AND CONDITIONS

- 1. The terms and conditions set out within this Xerox Free Extended Warranty Program (“FEW Program”) are offered by Xerox Limited,** incorporated in England and Wales with its registered office at Building 4, Uxbridge Business Park, Sanderson Road, Uxbridge Middlesex UB8 1DH, UK (“Xerox”) and may be administered by other Xerox affiliates in the Eligible Countries. By submitting this online application, you agree to these terms and conditions (the “Agreement”).
- 2. Eligible Equipment:** The FEW Program is made available to end users (“end user” or “you”) with Eligible Equipment. “Eligible Equipment” are Xerox® Branded Printers or Multifunction Devices in the configuration specified in Table A and that are located in Austria, Belgium, Denmark, Finland, France, Germany, Italy, Luxembourg, the Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the UK (“Eligible Countries”).
- 3. End Users:** All end users must be resident in the Eligible Countries. Xerox Warranty (as defined below) is not available to employees, resellers, agents, distributors or channel partners of Xerox (such persons shall not enter claims on behalf of end users) or to any end user where participating in the FEW Program would violate any laws, regulations or policies.
- 4. (a) Eligibility Criteria:** An end user may claim a free one-year extension to their Eligible Equipment’s current and existing Xerox Warranty, subject to meeting the following eligibility criteria:
  - the end user purchases a new full set of Xerox genuine and recommended supplies in the European Union and/or European Free Trade Association and/or the UK. Xerox genuine and recommended supplies are those as listed in Table B (“Eligible Supplies”) for use on the Eligible Equipment. For colour printers and multifunction devices, this means Cyan, Magenta, Yellow and Black Xerox genuine supplies. For mono printers and multifunction devices, this means Black Xerox genuine supplies; and
  - the end user purchases such Xerox genuine and recommended supplies within the last 6 months prior to the expiry of their then existing Xerox Warranty (“Claim Period”); and
  - the end user claims their free one-year warranty prior to the expiry of their then existing Xerox Warranty.

**(b)** Claim as referred to above shall mean the date that complete, accurate and material information is submitted to Xerox in writing by the end user for the purposes of making a claim (as further detailed in Clause 7 below).

**(c)** Subject to meeting the above eligibility criteria, the end user may only claim a maximum of 4-years free warranty cover in accordance with this FEW Program in addition to the first year free Xerox manufacturer warranty, providing a possible total warranty cover for Eligible Equipment of 5 years maximum from original sale date of Eligible Equipment.

**(d)** The FEW Program cannot be combined with any other extended Xerox Warranty offerings.

**(e)** Products within one year of their end of service date are not eligible for the FEW Program. End of service date for products means the last date on which Xerox will provide any service or spare parts for those products. End of service products are typically those where 5 years have elapsed since Xerox or any Xerox affiliates sold such products as new.
- 5. Xerox Warranty:** The “Xerox Warranty” is the provision by Xerox or any Xerox affiliates of repair and parts for the Eligible Equipment subject to the terms and conditions of the applicable warranty offering or service agreement and the terms of this FEW Program. The end user is deemed to have accepted the terms and conditions of this Agreement upon making a claim. Xerox is not responsible for ensuring that the Xerox Warranty is suitable for your required purpose.
- 6. Period of Each Warranty:** A successfully claimed Xerox Warranty extension shall start on the day after the expiry of your current Xerox Warranty and shall continue for **12 months** unless this Agreement is terminated. In addition to Xerox’s other rights, if Eligible Equipment is no longer supported by Xerox (Eligible Equipment are usually supported for 5 years after new sales are discontinued i.e., there is no End of Service notice), Xerox reserves the right to terminate the FEW Program. Use of non-recommended Xerox supplies shall make the end user ineligible for Xerox Warranty, give rise to the right for Xerox to terminate the Agreement or invalidate a request for repair or parts under a Xerox Warranty (unless in any such case Xerox agrees otherwise).
- 7. Claims:** To make a claim for a free Xerox Warranty, the end user must at their own cost submit complete, accurate and material information in the format requested by Xerox. Xerox may request, and the end user must respond to such requests (at their own cost), for information and supporting documentation such as proof of purchase/lease/rental of Eligible Equipment and Eligible Supplies, page count, information on warranty status, serial number, model, version of the operating system and software installed.
- 8. Claims can be submitted at:** <https://warranty.external.xerox.com>. Customers should select their country and then Sign In or Register As a User. They will then be requested to submit specific information required to complete a claim.
- 9.** Any “approved” claims for this FEW Program remain provisional on any conditions in this Agreement being met. Any failure to meet these conditions at any time (even during the provision of any existing Xerox Warranty) will invalidate the claim and end this Agreement. Claims with missing or incorrect information or supporting documents submitted outside the applicable relevant Claim Period will be not be considered, unless Xerox agrees to such application in writing. Xerox reserves the right to audit all claims to ensure adherence to these terms and conditions. The end users shall fully co-operate with Xerox and provide relevant additional information and supporting documents (at their own cost) within a reasonable time upon Xerox’s request.
- 10.** Only one claim for the extended Xerox Warranty available under this FEW Program can be made per Claim Period. Claims made during a Xerox Warranty but outside the Claim Period will not be eligible. Multiple purchases of Eligible Supplies during a Claim Period do not entitle the end user to multiple and consecutive Xerox Warranty coverage. Subject to the foregoing, only one claim can be made per 365 days.
- 11. Limitation of Liability:** Nothing herein shall limit or exclude Xerox’s or any Xerox affiliate’s liability (i) for death or personal injury caused by its negligence or (ii) for fraud or (iii) (if an end user is a consumer) for breach of any term implied by statute, or (iv) for any liability which cannot be excluded by law.

**12.** Subject to Clauses 11 and 13, Xerox or any Xerox affiliate will not be liable whether in contract, tort (including negligence) or otherwise for any loss or damage caused by it or its employees, Xerox resellers, agents, distributors or channel partners under and/or in connection with this FEW Program:

- i. where such loss or damage is not a reasonably foreseeable result of any such breach; or
- ii. for any increase in loss or damage resulting from breach by you of any term or condition; or
- iii. for any losses that relate to a business operated by the end user (including without limitation lost data, lost profits or business interruption).

**13.** Subject to Clause 11, if you are not a consumer, Xerox and Xerox affiliate's maximum liability whether in contract, tort (including negligence) or otherwise for any loss or damage caused by it or its employees, Xerox resellers, agents, distributors or channel partners under and/or in connection with this FEW Program shall be limited to a sum equivalent to the amount which you paid for the Eligible Supplies but in no event shall exceed one thousand pound sterling (£1000) or the local currency equivalent.

**14.** Data Protection Notice: The end user authorises Xerox to process any personal information, including the end user's name, address, telephone number and email address solely in connection with this FEW Program and fulfilling any Xerox Warranty. The end user acknowledges its right to change or remove personal information by contacting Xerox as outlined in its Privacy Policy on [www.xerox.com](http://www.xerox.com). The end user agrees to the sharing of personal information between Xerox affiliates within the UK, European Economic Area, Switzerland and the United States to fulfil the purpose of this FEW Program and Xerox Warranty. Xerox warrants that, having regard to the state of technological development and the cost of implementing any measures, it will take:- (a) appropriate technical and organisational measures against the unauthorised or unlawful processing of personal information and against the accidental loss or destruction of, or damage to, personal information to ensure a level of security appropriate to the harm that might result from such unauthorised or unlawful processing or accidental loss, destruction or damage and the nature of the data to be protected; and (b) take reasonable steps to ensure compliance with those measures. Xerox will share your personal information with third parties such as contractors, outsourcing partners and subcontractors who may help fulfil this FEW Program or provide the services under the Xerox Warranty.

These terms and conditions do not affect your right to cancel your participation in the FEW Program or Xerox Warranty.

**GENERAL TERMS**

- 16.** Xerox may, at any time and at its sole discretion, terminate this FEW Program or may change or waive the application of any of these terms and conditions without notice.
- 17.** The benefit(s) available under this FEW Program cannot be combined with any other program, promotion or other benefit(s) unless specifically permitted by this FEW Program or as otherwise permitted by Xerox.
- 18.** Xerox may transfer or assign this Agreement without consent at its sole discretion. The end user may not assign or transfer this Agreement to anyone, unless agreed to by Xerox.
- 19.** The end user agrees that any information or data disclosed to Xerox under this FEW Program is not confidential or proprietary to the end user.
- 20.** No Xerox reseller, agent, distributor or channel partner is authorised to make any modification, extension, or addition to the terms of this FEW Program or Xerox Warranty. Xerox and other Xerox affiliates are not responsible nor liable for any false, inaccurate or incomplete statements made by third parties in connection with this FEW Program or Xerox Warranty.
- 21.** This Agreement shall be governed in accordance with the laws of England and Wales, and the parties submit to the exclusive jurisdiction of the courts of England and Wales. Consumers may have additional consumer law rights under consumer laws of their country, and this Clause 21 is not intended to limit such rights.
- 22.** These terms and conditions set out the entire agreement between the parties and supersede all prior oral or written agreements, arrangements or understandings between them.
